Monthly board meetings are held the 1st Monday of every month (if a holiday it will be the 2nd Monday). Meetings begin at 7:00PM and are held at the North Carroll Senior Center, 2328 Hanover Pike, Hampstead, MD 20174. Everyone is welcome and encouraged to attend. 2

HOA dues are paid annually and due by February 28th of each year. Dues invoices are sent out the beginning of January. Payments made after March 30th will incur a \$20 late fee plus interest.

Important information you will need to know: 2

The speed limit in our community is 25 MPH. It is imperative everyone obey the speed limit. We are a community made up of families with children of ALL ages. Please help keep it safe. 2

Trash and recyclables are picked up every Tuesday. These items should be set out for pick-up the evening before. 2

If you are a pet owner, it is your responsibility to clean up after your pet. When walking your dog remember to take trash pages with you. This is not only a rule within NCFs but a county law as well.

Architectural Requirements: To insure our community continues to shine and look new there are architectural standards in place. You must obtain approval from the Architectural Committee BEFORE you do any exterior

improvements to your home or lot. Such improvements include: decks, patios, fences, pools, landscaping, tree planting/removal, door/shutter color change just to name a few. A complete list can be found on our website in our Architectural Guidelines along with the Architectural Modification Form. In order to start the process you must complete an Architectural Modification Form and submit your detailed plans to the committee in writing via mail or email. Approvals may take up to 60 days so please take this into consideration. Failure to obtain prior approval can result in fines and even the project being removed.
